WITH HUNDREDS OF POTENTIAL THERAPEUTIC INTERVENTIONS UNDER CONSIDERATION, MANY OF THEM INITIATED BY RESEARCH INSTITUTIONS IN SMALL, UNDERPOWERED, NON-RANDOMIZED TRIALS, A FIRST ORDER OF BUSINESS WAS TO IDENTIFY AND FOCUS CRITICAL RESOURCES ON THE MOST PROMISING CANDIDATES. ACTIV SIFTED THROUGH HUNDREDS OF POTENTIAL THERAPEUTIC CANDIDATES TO PRIORITIZE THOSE MOST SUITABLE FOR CLINICAL DEVELOPMENT AND THEN HELPED DEVELOP A ROBUST, CENTRALIZED SUITE OF "MASTER PROTOCOL" CLINICAL TRIALS SPONSORED BY NIH AND FUNDED BY OPERATION WARP SPEED, IN WHICH TO TEST THEM. MASTER PROTOCOLS ALLOW RESEARCHERS TO EVALUATE MULTIPLE TREATMENT OPTIONS AT ONCE AGAINST A SINGLE CONTROL ARM, MAKING TRIALS MUCH MORE EFFICIENT AND GETTING POTENTIALLY LIFESAVING TREATMENTS EVALUATED AT MULTIPLE HOSPITALS AND CLINICS MORE EFFECTIVELY. ACTIV WAS CRITICAL TO IDENTIFYING, PRIORITIZING AND STANDARDIZING THE RESOURCES NEEDED TO PERFORM PRECLINICAL TESTING ON PROMISING THERAPEUTIC AGENTS PRIOR TO TESTING IN HUMANS.

ACTIV ALSO ENABLED VACCINE DEVELOPERS TO COLLABORATE IN THE DEVELOPMENT OF HARMONIZED PROTOCOLS FOR VACCINE EFFICACY TRIALS SO THAT FINDINGS COULD BE MORE EASILY COMPARED AND ASSISTED FDA IN UNDERSTANDING THE REQUIREMENTS FOR EARLY USE AUTHORIZATIONS FOR THESE VACCINES. IN CONCERT WITH GOVERNMENT AND COMPANY EFFORTS, ACTIV PLAYED AN IMPORTANT SUPPORTING ROLE IN THE DEVELOPMENT OF COVID-19 VACCINES IN A BREATHTAKING 11 MONTHS, COMPARED WITH THE TEN YEARS OR MORE OFTEN REQUIRED.

NEW GENETIC BIOCONTROL TECHNOLOGIES COULD MAKE IT POSSIBLE TO REDUCE THE TOLL OF MALARIA EITHER BY REDUCING THE REPRODUCTION OF MALARIA-CARRYING MOSQUITOES, SO FEWER WILL BE PRESENT TO SPREAD DISEASE, OR BY DECREASING THEIR ABILITY TO CARRY THE MALARIA PARASITE. WITH MOSQUITOES NO LONGER TRANSMITTING MALARIA, INDIVIDUALS WOULD BE FREE OF SPECIAL PROTECTION MEASURES AND COMMUNITIES WOULD ENJOY

IT'S AN INSPIRING YET CHALLENGING VISION, RAISING IMPORTANT TECHNICAL, REGULATORY AND ETHICAL QUESTIONS. AND WHILE THE SCIENTIFIC COMMUNITY HAS ESTABLISHED PROCEDURES FOR EVALUATING TOOLS LIKE VACCINES, MEDICINES AND INSECTICIDES, SUCH PROCEDURES HAVE NOT YET BEEN DEVELOPED FOR GENETIC BIOCONTROL. BUILDING ON MORE THAN A DECADE OF FNIH WORK, GENECONVENE BRINGS TOGETHER SCIENTISTS, REGULATORS, POLICYMAKERS AND OTHER STAKEHOLDERS TO DEVELOP BEST PRACTICES AND ENSURE THAT GENETIC BIOCONTROL RESEARCH ADDRESSES IMPORTANT PUBLIC HEALTH PRIORITIES ETHICALLY, SAFELY AND EFFECTIVELY.

GENECONVENE ALSO SERVES AS A GLOBAL HUB FOR RELEVANT, TIMELY AND ACCURATE KNOWLEDGE. A KEY RESOURCE FOR THIS WORK IS THE GENECONVENE VIRTUAL INSTITUTE, ALSO LAUNCHED IN 2020. THE VIRTUAL INSTITUTE IS AN ONLINE LIBRARY HOUSING SCHOLARLY LITERATURE, POLICY PAPERS, OPINION PIECES, EDUCATIONAL VIDEOS AND MEDIA COVERAGE. GENECONVENE ALSO HOSTS REGULAR WEBINARS THAT PROVIDE DIVERSE, MULTIDISCIPLINARY PERSPECTIVES ON THE SCIENTIFIC, SOCIAL AND ETHICAL DIMENSIONS OF GENETIC BIOCONTROL TECHNOLOGIES.

COMMITTED TO ENSURING THAT EVERYONE CHARGED WITH MAKING DECISIONS ABOUT GENETIC BIOCONTROL FROM SCIENTISTS TO POLICYMAKERS TO COMMUNITIES HAS THE KNOWLEDGE THEY NEED TO MOVE FORWARD SAFELY AND ETHICALLY.

A-PLUS TRIAL

EVERY YEAR GLOBALLY, MORE THAN TWO MILLION BABIES DIE SHORTLY AFTER BIRTH, WHILE NEARLY 300,000 WOMEN DIE FROM PREVENTABLE CAUSES RELATED TO PREGNANCY AND CHILDBIRTH. MANY OF THESE DEATHS ABOUT 10 PERCENT OF MATERNAL MORTALITY AND ABOUT 16 PERCENT OF NEONATAL MORTALITY ARE CAUSED BY INFECTION, AND MANY OCCUR IN LOW- AND MIDDLE-INCOME COUNTRIES. DESPITE THE WIDESPREAD AVAILABILITY OF ANTIBIOTICS, THERE HAS BEEN LITTLE RECENT PROGRESS IN REDUCING THIS TOLL.

IN 2020, THE FNIH ANNOUNCED THE LAUNCH OF A NEW INITIATIVE TO ADVANCE RESEARCH ON A SIMPLE BUT INNOVATIVE INTERVENTION THAT COULD BE A GAME-CHANGER FOR PREVENTING MATERNAL AND NEWBORN DEATH. LAUNCHED IN PARTNERSHIP WITH THE EUNICE KENNEDY SHRIVER NATIONAL INSTITUTE OF CHILD HEALTH AND HUMAN DEVELOPMENT WITH FUNDING FROM THE BILL & MELINDA GATES FOUNDATION, THE MULTI-SITE EFFICACY AND SAFETY TRIAL OF INTRAPARTUM AZITHROMYCIN IN LOW- AND MIDDLE-INCOME COUNTRIES, ALSO CALLED THE A-PLUS STUDY, WILL ASSESS HOW WELL A SINGLE ORAL DOSE OF AZITHROMYCIN DURING LABOR CAN PROTECT THE HEALTH OF BOTH MOTHERS AND NEWBORNS.

RECENT PRELIMINARY TRIALS OF PROVIDING AZITHROMYCIN DURING LABOR IN THE U.S. AND THE GAMBIA HAVE SHOWN PROMISING RESULTS, BUT A MUCH LARGER STUDY IS NEEDED TO CONFIRM THESE FINDINGS. THE A-PLUS TRIAL WILL ENROLL 34,000 WOMEN ACROSS SOUTH ASIA, SUB-SAHARAN AFRICA AND CENTRAL AMERICA.

SYMPTOMS OFTEN EMERGE DURING THE TEENAGE YEARS OR EARLY ADULTHOOD, BUT THIS SERIOUS MENTAL DISORDER IS USUALLY NOT DIAGNOSED UNTIL PSYCHOSIS OCCURS, WHICH MAY BE SEVERAL YEARS LATER. DIAGNOSING AND TREATING SCHIZOPHRENIA SOONER COULD HELP YOUNG PEOPLE STRUGGLING WITH ITS EARLY SYMPTOMS AND POTENTIALLY DELAY OR STOP DISEASE PROGRESSION.

THE FNIH'S ACCELERATING MEDICINES PARTNERSHIP IN SCHIZOPHRENIA (AMP SCZ), LAUNCHED IN SEPTEMBER 2020, AIMS TO IDENTIFY EARLY INDICATORS OF THE DISEASE, WHICH WILL ALLOW RESEARCHERS TO TEST NEW TREATMENTS THAT COULD DIAGNOSE AND HELP PATIENTS IN ITS INITIAL STAGES. THIS FIVE-YEAR, \$99 MILLION PROJECT BRINGS TOGETHER NINE PARTNERS, INCLUDING GOVERNMENT AGENCIES, INDUSTRY, PRIVATE FOUNDATIONS AND PATIENT-CENTERED NOT-FOR-PROFIT ORGANIZATIONS, TO COLLABORATE IN THIS CRITICAL WORK. AND ONLY A HANDFUL OF APPROVED TREATMENTS. THE AVAILABLE TREATMENTS CAN ALLEVIATE THE SYMPTOMS OF DISEASE BUT CANNOT STOP IT FROM CONTINUING TO DAMAGE THE BRAIN. SCIENTISTS ALSO NOW BELIEVE THAT ALZHEIMER'S DISEASE MAY BEGIN DECADES BEFORE OUTWARD SIGNS, SUCH AS MEMORY LOSS, BECOME APPARENT.

IN MARCH 2020, THE FNIH BIOMARKERS CONSORTIUM LAUNCHED A BOLD NEW PROJECT PLASMA A AS A PREDICTOR OF AMYLOID POSITIVITY IN ALZHEIMER'S DISEASE INTENDED TO IDENTIFY SIMPLE, EFFECTIVE TESTS TO DETECT EARLY ALZHEIMER'S DISEASE, PAVING THE WAY FOR POTENTIAL TREATMENTS THAT COULD STOP THE DISORDER BEFORE IT HAS SERIOUSLY DAMAGED THE BRAIN.

THE NEW FNIH PROJECT BRINGS TOGETHER GOVERNMENT, ACADEMIC, NOT-FOR-PROFIT AND INDUSTRY EXPERTS TO COMPARE SIX DIFFERENT POTENTIAL PLATFORMS TO MEASURE BETA AMYLOID, OR ABETA, IN A PERSON'S BODY. DEPOSITS OF ABETA IN THE BRAIN CAUSE PLAQUES BETWEEN NERVE CELLS AND ARE THOUGHT TO PLAY A ROLE IN ALZHEIMER'S DISEASE. THE TESTS UNDER EVALUATION MEASURE LEVELS OF ABETA IN PLASMA, REQUIRING ONLY A SIMPLE BLOOD DRAW. THE GOAL OF THE PARTNERSHIP IS TO DETERMINE WHICH PLATFORMS FOR MEASURING ABETA IN BLOOD PLASMA CAN ACCURATELY PREDICT THE PRESENCE OF BETA AMYLOID IN THE BRAIN.

AN ABETA BLOOD TEST COULD REPLACE CURRENT TOOLS FOR MEASURING BETA AMYLOID, SUCH AS PET SCANS OR TESTING OF CEREBROSPINAL FLUID, WHICH CAN BE INVASIVE, EXPENSIVE AND PAINFUL. THIS WOULD IMMEDIATELY MAKE CLINICAL TRIALS FOR ALZHEIMER'S DISEASE PREVENTION AND TREATMENT EASIER ON RESEARCHERS AND TRIAL VOLUNTEERS. OVER THE LONGER TERM, THE TEST COULD SPEED THE SEARCH FOR NEW TREATMENTS THAT TARGET THE DISEASE IN

EACH YEAR, THE FNIH BESTOWS THE CHARLES A. SANDERS, M.D., PARTNERSHIP AWARD TO RECOGNIZE PEOPLE AND/OR ORGANIZATIONS THAT HAVE MADE SIGNIFICANT CONTRIBUTIONS TO THE ORGANIZATION'S EFFORTS TO BUILD, IMPLEMENT AND NURTURE PUBLIC-PRIVATE PARTNERSHIPS IN SUPPORT OF THE MISSION OF THE NIH.

AS NIAID DIRECTOR SINCE 1984, DR. FAUCI HAS BEEN AT THE FOREFRONT OF THE SCIENTIFIC RESPONSE TO PREVENT, DIAGNOSE AND TREAT THE WORLD'S MOST VEXING INFECTIOUS DISEASES, INCLUDING HIV/AIDS, ZIKA, EBOLA AND MANY OTHERS. OVER THE COURSE OF HIS EXTENSIVE CAREER, DR. FAUCI HAS OVERSEEN A WIDE VARIETY OF RESEARCH COLLABORATIONS BETWEEN NIAID AND THE FNIH, INCLUDING WORK IN AFRICA ON HIV/AIDS, AS WELL AS TUBERCULOSIS VACCINES, TREATMENTS AND BIOINFORMATICS. HE CURRENTLY SERVES ON THE EXECUTIVE COMMITTEE OF THE FNIH-COORDINATED ACCELERATING COVID-19 THERAPEUTIC INTERVENTIONS AND VACCINES (ACTIV) INITIATIVE, A PUBLIC-PRIVATE PARTNERSHIP TO EXPEDITE DEVELOPMENT OF VACCINES AND TREATMENTS FOR COVID-19.

"THE GENEROSITY OF THE PROGRAM HAS BEEN A MAJOR BOON TO OUR PATIENTS AND OUR PROGRAM," SAYS DR. STEVEN HOLLAND, DIRECTOR, DIVISION OF INTRAMURAL RESEARCH AT NIAID.
